O R D E R

SLP (C) Nos.7220-7221/2017:

Our attention is invited to Orders passed by this Court on 05.09.2023, 12.09.2023 and 12.12.2023. We find that I.I.T. (Delhi) has not complied with the directions issued by this Court and therefore I.I.T. (Delhi) owes an explanation to this Court. We direct an appropriate officer of I.I.T. (Delhi) to file a detailed affidavit explaining the reasons for non-compliance with the directions referred to above. The affidavit shall be filed by the I.I.T. (Delhi) by 8<sup>th</sup> May, 2024 and copies thereof shall be served to the learned counsel appearing for the parties.

List on 10<sup>th</sup> May, 2024 for considering compliance by the I.I.T. (Delhi). In the meanwhile, we direct the Commissioner of the Municipal Corporation to supply copies of the orders passed in appeals dealing with the issue of eligibility to the advocate for the petitioners in W.P.(C) No.788/2021.

Those who file affidavits, reports, applications, pleadings, etc. shall ensure that copies thereof are filed on record of both the SLP and Writ Petition (C) No.788/2021.
