O R D E R

We propose to appoint I.I.T, Delhi, to go into the issue of habitability of the premises (1072 flats) which are being offered to the eligible persons by way of rehabilitation. The habitability will include proper supply of water including drinking water, availability of drainage system and sewerage system. It is also necessary to ascertain whether there are seepages.

The Commissioner of the Municipal Corporation, Faridabad, will ascertain from the Director, I.I.T., Delhi whether I.I.T. will be in a position to undertake this exercise, and if yes, within what time the assignment can be completed.
