UPON hearing the counsel the Court made the following  
O R D E R

We have perused the affidavit of Mr. Amitabh Mukherji, Deputy Registrar (Legal) filed on behalf of I.I.T (Delhi) on 1<sup>st</sup> August, 2024. We permit I.I.T (Delhi) to take assistance of Rodic Consultants Private Limited more particularly described in paragraph 3 of the affidavit. The Municipal Corporation of Faridabad shall formally issue a letter to Rodic Consultants Private Limited of its appointment to assist I.I.T (Delhi). Needless to add that necessary remuneration to the said company shall be paid by the Corporation.

A concern is expressed in paragraph 4 of the affidavit about the safety by saying that on earlier occasion, when the team members of the I.I.T (Delhi) visited the site, they were surrounded by a large mob.

We, therefore, direct I.I.T (Delhi) to give intimation to the concerned local Police Station in advance about the visit of its team or team of Rodic Consultants Private Limited to the site. The Officer in charge of concerned police station shall provide not only adequate security to the team members but also will ensure that large number of people do not assemble at the time of the site visit. I.I.T will submit copy of this order along with its application to the Officer in charge to the Police Station.

We grant time to I.I.T (Delhi) to file the report till 9<sup>th</sup> September, 2024. Copies thereof be supplied in advance to the learned counsel appearing for the parties.

For considering the report, list on 13<sup>th</sup> September, 2024.

Needless to add that when teams of I.I.T (Delhi) or Rodic Consultants Private Limited appointed by the I.I.T (Delhi) visit the site, they will give an advance intimation of their visit to the concerned officer of the Municipal Corporation, Faridabad. On receipt of the intimation, the Municipal Corporation, Faridabad shall also get in touch with the local police station and depute its own officers for aiding the police machinery.

Earlier direction permitting a representative of the petitioner to remain present at the time of site visit will continue to operate.
