UPON hearing the counsel the Court made the following O R D E R

The Registry to forward a copy of this order to Mr. Amitabh Mukherji, Deputy Registrar (Legal) on behalf of Indian Institute of Technology (IIT), Delhi. Even as of today, there is no report submitted by IIT, Delhi. Therefore, IIT, Delhi must file a report to this Court for showing compliance. In fact, under the order dated 2nd August, 2024, IIT, Delhi was directed to file report by 9th September, 2024. There is not even an application

or report submitted by IIT, Delhi for extension of time.

At this stage, the learned senior counsel appearing for the petitioners in Writ Petition (Civil)No.788 of 2021 states that *solatium* at the rate of Rs.2,000/-(Rupees two thousand) per month has not been paid after June, 2023. He states that 245 eligible persons have not been allotted accommodation.

We direct the learned senior counsel appearing for the petitioners in Writ Petition (Civil)No.788 of 2021 to supply the names of 245 allottees to the learned counsel appearing for the Municipal Corporation. The learned counsel appearing for the Municipal Corporation shall respond on both the aspects before the next date.
