UPON hearing the counsel the Court made the following
O R D E R

As far as the affidavit dated 8th November, 2024 filed by the Commissioner of the Faridabad Municipal Corporation is concerned, we direct that a copy of the same to be furnished to the learned counsel appearing for the respondents in SLP (C) Nos.7220-7221/2017 along with the list of names referred in the affidavit.

We have perused the affidavit of the Indian Institute of Technology, Delhi (I.I.T.). It is reiterated by the learned counsel appearing for the I.I.T. that the I.I.T. is not going to charge any remuneration.

Considering the fact that the report on the condition of 1072 flats is to be submitted, we do not find that the amount quoted by M/s. Rodic Consultants Pvt. Ltd. is excessive. We, therefore, direct the Faridabad Municipal Corporation to release the amount in

terms of the letter dated 4th November, 2024. The amount to be paid within a period of two weeks from today. Thereafter, the Agency appointed by the I.I.T. shall immediately commence the work.

As regards the affidavit of the Commissioner of the Faridabad Municipal Corporation, we will hear the parties on 6th December, 2024.

The I.I.T. will file an interim report of the work done on or before 31st December, 2024.

The copies of the pleadings and other documents filed on record shall be supplied to the learned counsel appearing for the parties in the connected Petitions.
